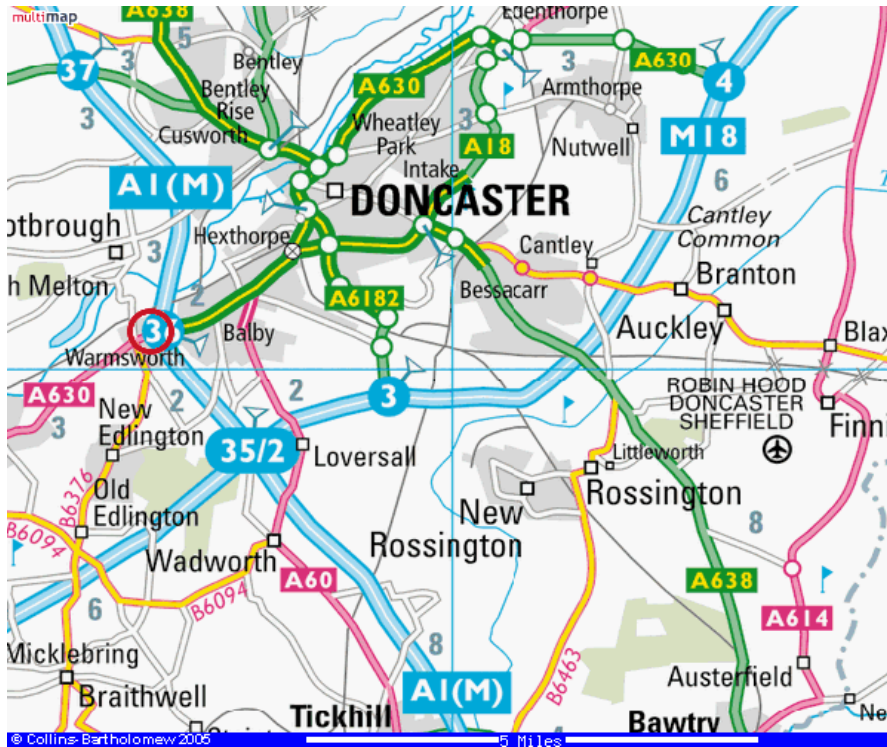

Doncaster A1(M) Junction 36

At Junction 36 turn down A630 towards Rotherham (*not* Doncaster town centre), hotel entrance is the second left turn, which is only about 200 yards from the junction.
